# **Safeguarding Training Delivered**

Fifteen full day training sessions took place between September 2021 and June 2022. Further training days are scheduled to take place before the end of this year. Those required to attend have been contacted. In September 2018 parish safeguarding visits commenced. They were interrupted due to Covid during 2020 and 2021 but by November of 2021 all thirty-four parishes received a visit. This year the parish visits are being replaced by four information / update sessions which will take place during September and October 2022.



# **Annual Safeguarding Sunday**



Our sixth annual Safeguarding Sunday will be held throughout the diocese on the weekend of the 24<sup>th</sup> & 25th of September 2022. The purpose of Safeguarding Sunday is to create a greater awareness of safeguarding in our parishes and to recognise the significant contribution of the faithful in ensuring that our diocesan safeguarding children policy and our diocesan adult safeguarding policy are being

adhered to. Special prayers of the faithful and homily notes have been prepared and distributed to all the clergy for inclusion in the weekend liturgies.

## Guidance on the Use of Photography

The Church only has responsibility for safeguarding in relation to the use of photography if it plans to use the photographs for Church purposes. Photographs taken at events organised by family and schools such as First Communions, weddings or Confirmations (including when the photographer is employed by the school or family for these occasions) do not fall under the responsibility of the Church, unless they are being taken for Church purposes. ## Parish Audits 2022

In 2021, the National Board for Safeguarding Children advised dioceses that parish audits had resumed. We appreciate that there has been very little engagement with children/young people due to Covid but we would encourage you to use the parish audit as a reminder of what needs to be in place as normal activity resumes. The return date for this year's audit is 17<sup>th</sup> October 2022.

## **Risk Assessment**

The National Board for Safeguarding Children has indicated that Tusla is currently reviewing Child Safeguarding Statements with reference to how local risk assessments are conducted. This is in the context of the child safeguarding policy which requires that a written risk assessment is carried out on all ministries with children. Each ministry must be reviewed at parish level, by those involved and safeguards put in place to minimise risk. In relation to children's ministries at local level the focus should be on risk assessment in relation to safeguarding issues.

A risk assessment is an exercise where an organisation examines all aspects of its service from a safeguarding perspective, to establish whether there are any practices of the service that have the potential to put children at risk. The Church is one such organisation. Risk assessments should be reviewed periodically as the operating environment changes or when new information on risks becomes available. Risk assessments are carried out at parish level for every activity involving children.

## Parish Safeguarding Representatives

In each parish one or two safeguarding representatives work alongside the parish priest, leaders and volunteers to raise awareness of safeguarding best practice, offering help and practical support where necessary. Voluntary safeguarding representatives have participated in a training programme developed specifically for the role by the National Board for Safeguarding Children in the Catholic Church and delivered by diocesan trainers. Safeguarding representatives agree to hold the role for four years. Their role is not to hear concerns, allegations or disclosures of abuse but rather to ensure that people have access to the contact details for Tusla, the Gardaí and the designated liaison persons. These contact details are displayed at the main entrance of every church in the diocese.



#### Parish Safeguarding Representatives are responsible for promoting safeguarding by:

- 1. Raising awareness of safeguarding by holding an information session at least once a year which anyone from the parish can attend but must be attended by leaders and volunteers of children's activities.
- 2. Disseminating information on safeguarding standards and circulating that information widely.
- 3. Ensuring Church activities are provided in a way that ensures the safety and well being of the children involved.
- 4. Ensuring that the contact details of the designated liaison persons, the Gardaí and Tusla are widely publicised.



#### **Parish Leaders and Volunteers:**

- a) A leader is the person with overall responsibility for the activity. This person is responsible for supervising the children.
- b) A volunteer is someone who assists the leader in facilitating the activity. This person is responsible for helping the leader supervise the children.
- c) A volunteer with a non-supervisory role is someone who assists the leader in facilitating the activity but does not supervise the children.

## **Feedback**

Feedback on our present safeguarding arrangements is always welcome and you are encouraged to do so. Each parish holds an annual safeguarding information session at which feedback on our safeguarding practices is sought from those who attend. Please give your feedback, thoughts and suggestions during these information sessions. The parish safeguarding representative will forward them to the diocesan safeguarding office. You can also give your feedback directly to the diocesan safeguarding office by contacting Suzie Duffy at safeguarding@kilmorediocese.ie
